The Government of the Republic of Namibia has received financing from the African Development Bank towards the cost of the Transport Infrastructure Improvement Project, and intends to apply part of the agreed amount for this *loan* to payments under the contract for Technical Assistant – Advisory/ Project Management services.

The services included under this project are the support to the Ministry of Works and Transport, as the Executing Agency of the project, in the management of the project. The Individual Consultant shall be engaged as a Technical Assistant for Advisory/ Project Management to support the Executing Agency on a day-to-day basis over a period of 24 months, in the management of the project. The project encompasses two main interventions, viz.; (i) Upgrade of the Walvis Bay – Tsumeb railway line (Walvis Bay – Kranzberg Section) and (ii) Upgrade of Windhoek to Hosea Kutako International Airport Road – Section 2A. The Technical Assistant shall primarily support the Ministry in the management of the railway intervention, and is to be on a full time contractual basis for a period of 24 months, subject to a review after 12 month.

The Ministry of Works and Transport now invites eligible **individual consultants** to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services. **Individual Consultants** should indicate their interest in providing the services, and should provide a comprehensive CV clearly indicating their qualifications, demonstration of appropriate skills and experience in similar assignments with particular reference to rail infrastructure projects. Individuals should also indicate experience working in similar conditions.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's "**Rules and Procedures for the use of Consultants**" [May 2008 Edition, revised July 2012], which is available on the Bank's website at <http://www.afdb.org>.
